(RFP) for the 2025–2026 Cold Weather Shelter or Warming Center: Facility Use and Operational Services, which was released on Friday, September 12, 2025. All questions were due by Friday, September 26, 2025, at 2:00 p.m. Responses provided below are intended to clarify the RFP and assist potential proposers in preparing their submissions.
QUESTION 1: ELIGIBLE PARTICIPANTS Is it mandatory that the responding firm be a not for profit or faith based? Question Source: ☐ Pre-Proposal Conference
QUESTION 1 RESPONSE There is no mandatory requirement that respondents be nonprofit or faith-based organizations. The City of Gastonia welcomes proposals from all qualified organizations, including for-profit entities, provided the entity can meet the scope and requirements outlined in the RFP. The City of Gastonia encourages any entity type to submit a proposal, and appreciates the commitment to serving the community.
QUESTION 2: ZONING REQUIREMENTS I understand that some buildings are zoned for overnight or congregate shelter use. Are there specific zoning requirements for operating an overnight shelter, and could this pose a challenge? Question Source: Question Portal Pre-Proposal Conference
QUESTION 2 RESPONSE There are not any anticipated zoning challenges with this initiative. Because the shelter is Citysponsored and intended as a temporary emergency response, similar to responses for natural disasters, it is exempt from standard zoning restrictions. All facilities must comply with applicable North Carolina Fire Code requirements.
QUESTION 3: CITY FACILITIES AND ADULT RECREATION CENTER (ARC) USE I understand the City had considered using the Adult Recreation Center (ARC). Would the City be willing to provide a facility if an organization submitted a proposal to operate the shelter? Does the City currently have a facility, such as the ARC, available to serve as a cold weather shelter?

QUESTION 3 RESPONSE

No. The purpose of the RFP is to identify an organization that has an available facility and the ability to manage shelter operations. The City of Gastonia does not have a facility available nor is any of its facilities equipped to serve as a cold weather shelter.

QUESTION 4: FUNDING CLARIFICATION

Can you clarify the total funding amount of \$47,000 and the City's contribution of \$26,000? Is the \$47,000 inclusive of all services?

QUESTION 4 RESPONSE

Yes. The total funding available is \$47,000, which includes the City of Gastonia's contribution of \$26,000. The City partially funds police services in coordination with Gaston County, fully funds janitorial services, and contributes to the cost of a program support staff member—also in partnership with Gaston County. All services are covered within the \$47,000 total.

QUESTION 5: ALTERNATIVE CITY FACILITIES

If the Adult Recreation Center is not available, would the City consider offering another facility for shelter operations, or is that option off the table?
