Mon., Jan. 18	CoC Grants Review Committee reviews applications (applicants must have staff available by phone, 10:00am – 2:00pm for questions); applicants will be notified via email of the Committee's funding decisions/recommendations
Tues., Jan. 19	CoC Grants Review Committee will hear Appeals from any applicant agency regarding Committee's Threshold decisions (GoToMeeting link and scheduled 1:1 time will be provided); and final funding recommendations that will be reported to NC ESG are issued to applicants via email from Nancyw@cityofgastonia.com)
Thurs., Jan. 21	GLC-CoC Advisory Board approves Regional Application at its quarterly meeting. Collaborative Applicant submits Regional Application, via electronic submission
