## THE NC ESG RFA for ESG-CV is now available!

### NOTICE OF FUNDING AVAILABILITY

In order to address the COVID-19 pandemic, HUD is providing a supplemental allocation of ESG funds as authorized by the Coronavirus Aid, Relief, and Economic Security (CARES) Act, Public Law 116-136. These special **ESG-CV funds are to be used to prevent, prepare for, and respond to the coronavirus pandemic (COVID-19) among individuals and families who are homeless or receiving homeless assistance.** The funds will also support additional homeless assistance and homelessness prevention activities to mitigate the impacts of COVID-19. This **first allocation**, totaling \$1 billion, was based on HUD's FY 2020 formula allocation.

The North Carolina Department of Health and Human Services (DHHS) will administer North Carolina's non-entitlement ESG funds. NCDHHS is seeking proposals for up to \$16.58 million in Emergency Solutions Grant CARES Act (ESG-CV) funding for homeless services providers in North Carolina to assist with responding to the COVID-19 public health crisis, subject to the availability and appropriation of funds.
